ECIL/CSD/CCL/COALNET dated 15/05/2021 against our letter ref no: GM(Sys.)/2021-22/62/D dated 11/05/2021 where in ECIL was asked for time bound explanation with proper justification and documents regarding subletting of the job by hiring the entire manpower deployed at CCL through M/s Conacent Consulting Pvt. Ltd, Kolkata except the Project Manager without any prior approval from CCL in this regard.

ECIL's explanation in respect of subletting has not been found to be in accordance with the provisions of NIT/Tender document/Agreement and violating the terms and conditions as follows:

- 1. Clause no: 2.6: Instruction to Bidder
- 2. Clause no: 3(B): Technical Terms & condition (Manpower Requirement)
- 3. Clause no: 10(f) & Clause no:13(XI): General Terms & Conditions

CCL's management has taken a serious note on above referred violations by ECIL in execution of the contract. As such, CCL hereby terminates the contract with ECIL for the subject work "to provide maintenance support for existing customized ERP type Application Software namely CoalNet at Central Coalfield Limited for three years" against the awarded work order GM(Sys.)/2020-21/46 /D dated 12/05/2020 with effect from 06-June-2021 on "as is where is basis" imposing penalty as per provisions of the terms and conditions of the Agreement.

ECIL is advised to handover the workflow along with access controls of entire Coal-Net Project (CCLHQ and Areas) to CCL representative latest by 07-June-2021.
