### NOTIFICATION

S.O. 717 WHEREAS by the notification of the Government of India in the Ministry of Energy (Department of Coal) No. S.O. 1312 dt. the 24th April, 1978, under sub-section (1) of section 7 of the Coal Bearing Areas (Acquisition and Development) Act, 1957 (20 of 1957), the Central Government gave notice of its intention to acquire the lands in the locality specified in the Schedule appended to that notification;

AND WHEREAS the competent authority in pursuance of section 8 of the said Act, has made his report to the Central Government;

AND WHEREAS the Central Government, after considering the report aforesaid, and after consulting the Government of Bihar is satisfied that the lands measuring 562.00 acres (approximately) or 227.43 hectares (approximately), described in the Schedule appended thereto, should be acquired;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 9 of the said Act, the Central Government hereby declares that the lands measuring 562.00 acres (approximately) or 227.43 hectares (approximately), described in the said Schedule, are hereby acquired.

The plans of the area covered by this notification may be inspected in the office of the Deputy Commissioner, Giridih (Bihar) or in the Office of the Coal Controller, 1, Council House Street, Calcutta or in the office of the Central Coalfields Limited (Revenue Section), Darbhanga House, Ranchi (Bihar).

Plot numbers acquired in village Makoli : 1(P), 78, 79(P), 86 to 93, 94(P), 98 to 106, 107(P), 119(P), 120.

Plot numbers acquired in village Gunjardih : 212(P).

Plot numbers acquired in village Chapri : 1439(P), 1440(P).

Boundary description:

A-B line passes through plot number 1439 in village Chapri.

B-C line passes along the the part common boundary of villages Dhorhi and Makoli.

C-D-E lines pass through plot numbers 1, 79, again 1, 94, again 1, (which forms part common boundary with New Selected Dhorhi Colliery) in village Makoli.

E-F-G-G/1 lines pass through plot numbers 1, 119, 107, 119 in village Makoli.

G/1-H line passes through plot number 119 in village Makoli (which forms part common boundary with Selected Dhorhi Colliery).

H-I-J lines pass along the part common boundary of villages Makoli and Tarmi, Gunjardih and Tarmi (which forms part common boundary with Tarmi Colliery).

J-K-L-M-N-O lines pass through plot number 212 in village Gunjardih, through plot number 1 in village Makoli and through plot number 1440 in village Chapri.

O-P-Q lines pass along Southern boundary of plot numbers 766, 767, 771, then along western boundary of plot numbers 771, 770 and 769, again passes along southern boundary of plot numbers 772, 797, 798, 799 and 800 in village Chapri.

Q-A line passes through plot number 1439 in village Chapri and meets at Starting point 'A'.
