





Sub: - Banning of of the Agency "M/s Nagendra Prajapati,", (PAN:- BCSPP9273K) from participating in future tenders in CCL for a period of 1 year.

Dear Sir,

- In response to your tender for the work of "Providing and fixing of Safety board for slogan, sign board bricks wall for safety slogan, whitewashing of various building of pit office and safety related hand rail at view point at Tetariakhar OCP, Rajhara Area" floated vide tender ID 2023\_CCL\_269786\_1, Award of Work was issued to you vide letter ref SO(Q)/RA/e-Award/2023-24/11 dated 07.06.2023.
- 2. As per the Award of Work and NIT clauses, you were required to deposit a sum of Rs 1,26,000 as Additional Performance Security Deposit(APSD) and Rs 7900.00 as Performance Security Deposit(PSD) in addition to already submitted EMD in the form of Govt Securities or FDR duly pledged in the favour of CCL, Rajhara Area or Demand Draft in favour of CCL, Rajahara Area within 21 days of award of the work, i.e. by 28.06.2023.
- 3. As per NIT clause no 4.2 of the Conditions of Contract,

Quote: In case the successful bidder fails to submit the Performance Security, if any, within the stipulated time then the award of work shall be cancelled with forfeiture of security /earnest money.

Additionally, the company shall ban such defaulting contractor from participating in future tenders in concerned Subsidiary/CIL HQ for a period of minimum one year from the date of issue of such letter.

4. As per Clause no. 19.2.ii of Conditions of Contract, CCL will ban such Contractors, if L1 bidder fails to submit PSD and/or fails to execute the contract within stipulated period.

- However, you failed to deposit PSD or APSD to the Rajhara Area, CCL within the timeline.
- 6.As you failed to submit the APSD or PSD within the scheduled timeline, your AOW has been cancelled and EMD forfeited by CCL,
- 7. Further, a show cause vide letter ref no. SO(Civil)/RA/2022-2023/136 dated 20/09/2023 was issued to submit reason as to why action towards "Banning of Business" should not be taken by CCL. You were requested to submit your response within 15 days of issue of the show-cause letter, which has not been replied by you.

In view of all the above, proprietor "M/s Nagendra Prajapati,", (PAN:- BCSPP9273K) is being banned from participating in future tender for a period of 01 (one) year in Central Coalfields Limited from the date of issue of this banning letter i.e. from 05.08.2024 to 04.08.2025.
