This in response to the above referred e-Tender, You i.e; **M/s. Panwa Traders, Contractor** [PAN :- **AFTPY5842A**] had submitted online tender offer for the above referenced work in the e-procurement Portal of Coal India Limited (<https://coalindiatenders.nic.in>) and become successful bidder, but due to false submission of Experience Certificate, penal action is being taken in addition to cancellation of your contract and forfeiture of all dues.

. An E-Tender open was invited vide ref. tender notice no. PE(E&M)/ SWG/E-tender/22-23/989 dt.02/01.2023 after obtaining administrative approval for the subject work from the Project Officer, SWG-GVP Ph-II OCP. Amounting to Rs.540788.00 only including GST towards the work "**Making of chemical earth pits (20nos.) in the erection of lightning aarestor of different loaction under mines for monsoon preperation of SWG-GVP Ph-II.OCP.**" The e-tender was opened on scheduled date and time.

The false Experience Certificate have led to failure of our contract/work. This is default in the part of the contractor. As per NIT Tender Notice Rule clause no. (vi) of Sl.No.2 page No.132 of "**General terms and conditions**" of the NIT, clause no. (vi) of Sl.No.132 of "Instruction to bidders" (Even though the bidders meet the above eligibility/qualifying criteria, they are subject to be disqualified if they have: a. Made misleading or false representations in the forms, statements and attachments submitted in proof of the qualification requirements) and guidelines for banning of business for CIL and its subsidiaries (Also incorporated in NIT), clause no. 2 (vi) Willful suppression of facts or furnishing or wrong information or manipulated or forged documents by the Agency or using any other illegal/unfair means, you are hereby banned/debarred from submitting bids in CCL/CIL & other subsidiary for a period of one year from the date of issue of this letter.

A letter was issued to M/s. Panwa Traders, Pipradih as per e-tender notice rule no.(vi) of Sl.No.2 page no.132. through official email vide out letter fer.no. PE(E&M)/GVP Ph-II/23-24/Action/07 dt.05.04.2023. M/s. Panwa Traders, Pipradih has given a written reply through his official e-mail against above mentioned letter. In this replied he admitted that has submitted forged/manipulate the experience certificate.


