An NIT bearing no. GM(NK)/EnM/eNIT/2023-24/190 dated 14.12.2023, Tender ID: 2023\_CCL\_296142\_1 for the work titled **Repair and Maintenance of 11kV Overhead line of KD Old Feeder supplying power to KD Old Colony and Jehlitand under KDH OCP, NK Area** was floated on CIL e-procurement Portal.

After opening of bid documents on scheduled date and time, M/s Uday Singh & Brothers, At: Purana Chief House, PO: Giddi A, Hazaribagh, Distt: Ramgarh (Jharkhand), 829108 was found L-1 bidder and after found techno-commercially eligible, M/s Uday Singh & Brothers was Awarded the work vide Award of Work No. GM(NK)/E&M/AOW/23-24/2163 dated 19.03.2024.
