Dear Sir,

Whereas the tender for the subject work was invited through GeM Portal vide NIT No.: CCL/GM(CMC)/Hazaribagh/GeM/2024/21 Date:01.06.2024 with Gem Bid No.-GEM/2024/B/5004310. The tender was awarded / LOA issued on 23.08.2024.

LOA was issued dated:23.08.2024 in which the contractor was required to submit the Performance Security Deposit (PSD) amounting to ₹1,24,47,308/- within 21 days of the issuance of the Letter of Acceptance (i.e till 12.09.2024).

It was requested by you for 14-day extension for submission of the PSD under clause 4.2 of the Service Level Agreement (SLA), vide letter no. AWX/Tapin (South)/2024/01 dated 12.09.2024. However, you failed to submit the PSD within the requested extension period i.e. by 26.09.2024.

Several letters were issued to deposit Performance Security Deposit within the timeline.

As per clause 4.3 of SERVICE LEVEL AGREEMENT/CONDITIONS OF CONTRACT of NIT

Quote

"In case the successful Bidder fails to submit the Performance Security and Additional Performance Security, if any, within the stipulated time then the award of work may be cancelled with forfeiture of the Bid Security/Earnest Money. Additionally, the Company shall debar such defaulting Contractor from participating in future tenders in concerned Subsidiary/CIL HQ for a period of minimum one year from the date of issue of such letter. In case of JV/CONSORTIUM/Partnership firm, the debarment shall also be applicable to all individual partners of JV/CONSORTIUM/Partnership firm."

Unquote-

In view of above, a show cause notice was served to you on your mail vide no: PO/TSOCP/OS Patch-6/AWX/Show_Cause/2024/753 dated 07.10.2024 to show cause as to why you should not be debarred for a period of 1 (One) year from participating in future tenders in CCL as per the terms of the NIT, where as you did not reply.

In view of above, you M/s AW XCACON are debarred from participating in tenders of CCL for a period of 01(One) year from date of issue of this letter.
