Dear Sir,

The subject work awarded to you was cancelled and Performance Security including EMD amounting to Rs.6,800.00, was also forfeited, as you have not submitted the balance Performance Security Deposit in the required forms i.e. Demand Draft or FDR or Govt. Securities duly pledged in favour of Central Coalfields Limited (CWS/CS), Barkakana within the stipulated time period.

As per clause no. 4 of GTC, "In case the successful bidder fails to submit the Performance Security, if any, within the stipulated time then the award of work shall be cancelled with forfeiture of the bid security/earnest money. Additionally, the company shall ban such defaulting contractor from participating in future tenders in concerned Subsidiary/CIL HQ for a period of minimum one year from the date of issue of such letter".
