ORDER FOR BANNING OF BUSINESS

A tender bearing NIT No.: P.E. (EnM)/ Karo OCP/ c-tender/ 2024-25/5, dated 14.06.2024, with tender ID: 2024_CCL_310502_1, and title "Dismantling, cutting, welding and laying of the 8 inch dia M.S. pipes, required for shifting of the location of the 2000 G.P.M. Pump, engaged in supplying water to the Reservoir Tank at Mine, w.r.t. Karo OCP, under BnK Area" was floated on CIL e-procurement portal.

After opening of the bid documents on the scheduled date and time, M/s Jai Hanuman Enterprises, Pan No. AWJPD9385N, GST no. 20AWJPD9385N1Z3, At- MQ 348 Subhash Nagar, Bermo, Bokaro Jharkhand 829104 was found as the L-1 bidder and after found techno-commercially eligible, M/s Jai Hanuman Enterprises was awarded the work.

Meanwhile, a complaint was received by a contractor, through e-mail to the undersign, claiming that the said firm has furnished false experience certificate, in order to qualify for the tender. The tender inviting authority i.e. P.E. (E&M), Karo OCP, was instructed to verify the experience, which was subsequently found to be forged one. Thereafter, the work order issued vide no. PE/E&M/Karo OCP/24-25/108 dated 28.09.2024 was cancelled after obtaining the competent approval. due violation of above mentioned NIT provisions by the contractor, M/s Jai Hanuman Enterprises.

The firm submitted forged document to qualify for the tender which is a **wilful suppression of the facts or furnishing of wrong information or manipulated or forged documents by the Agency or using any other illegal/unfair means, as per clause 20, 2(vi) of NIT.** Along with this, as per clause 20(4) of the NIT, *The debarment shall be for a minimum period of one year and shall be effective for the concerned Subsidiary for the tenders invited at Subsidiary level.*

A show cause notice was served to the contractor on the basis of principles of natural justice clearly mentioning all the potential penalties like debarment period of 1 year in CCL and Forfeiture of the PSD etc.

Under the facts and circumstances mentioned above, the business in the name and style of **M/s. Jai Hanuman Enterprises, Pan No. AWJPD9385N, GST no. 20AWJPD9385N1Z3, At- MQ 348 Subhash Nagar, Bermo, Bokaro Jharkhand 829104** is hereby banned for 01 (One) year from being eligible to submit bid in CCL as a whole with immediate effect.

This issues with the approval of the competent authority via e office no. 1579905.
