## ORDER FOR BANNING OF BUSINESS

An NIT No. GM(NK)/EnM/2024-25/144; Dated: 25.08.2024, for the work titled Hiring of 02 (Two) Nos. hard top covered jeep Diesel version (like Bolero, Tata Sumo or equivalent) on daily hiring basis (16-24 hours service alongwith two nos. Drivers) for a period of three years for its deployment under different Project/Units of NK Area floated via GeM Portal, GeM Bid Number: GEM/2024/B/5326367 dated 25.08.2024.

After techno-commercially eligible, M/s Chandra Bhushan Prasad At & PO: Dakra, Distt: Ranchi 829210, Jharkhand (L-1 bidder) was Awarded the work vide GeM Contract No. GEMC-511687761995121 dated 09.12.2024.


As per norms of ATC/Contract, Awardee had to deposit PSD amount and APSD amount. But M/s Chandra Bhushan Prasad failed to deposit the PSD and APSD amount within the prescribed 21-day period as per Clause No. 4.00 "Security Deposit" of Conditions of Contract.

One show cause vide no. GM(NK)/E&M/2024-25/1093 dated 20.01.2025 was issued to M/s Chandra Bhushan Prasad which has not been replied by him within the prescribed period. Accordingly Award of work was cancelled vide Letter No. GM(NK)/E&M/2024-25/1093 dated 20.01.2025.

Under the facts and circumstances mentioned above and in continuation to the Point no. (2) of Letter No. GM(NK)/E&M/2024-25/1093 dated 20.01.2025, the business in the name and style of M/s Chandra Bhushan Prasad At & PO: Dakra, Distt: Ranchi 829210, Jharkhand (PAN No. AKDPP7602G & GSTIN: 20AKDPP7602G1ZK is hereby debarred from participating in future tenders in CCL as a whole with immediate effect for a period of 01 (One) year.
