## "NOTICE TO COAL CONSUMERS"

## Sub: Refund of TCS Collected for the Financial year 2012-13 to 2017-18 in the year 2017-18

This notice is issued in compliance with the Hon'ble Jharkhand High Court's Judgement in case of M/s Adhunik Power & Natural Resources Ltd. in WPT No. 2023 of 2021 and also in respect of few coal purchasers, and also in compliance to the letter dated 10.07.2024 received from the Dy./ Asstt. Commissioner of Income Tax, TDS Circle, Ranchi, in respect of refund of TCS collected for financial year 2012-13 to 2017-18 from coal consumers as listed in Annexure-A.

The DCIT/ ACIT TDS Circle, Ranchi, vide his aforesaid letter, is ready to refund the TCS amount to CCL, provided an affidavit is furnished to the effect that the TCS certificates issued by CCL were not utilised by the coal purchasers for the getting adjustment of their demand / obtaining refund from income tax department or any other relevant authority and further the TCS certificates issued to the coal consumers in the said matter will be revoked by CCL.

As such, to process your refund, all coal buyers, who are willing to get refund are required to submit to CCL an affidavit duly notarised in the enclosed format as per Annexure-B along with an application confirming the amount of TCS eligible for refund as per the aforesaid order. On receiving such affidavit, the CCL will revoke the TCS certificates already issued to such coal buyer.

Thereafter, the refund will be processed by the IT department and will be refunded to CCL and in turn CCL will refund to such coal buyers. Be it noted that as per SOP dated 01/02<sup>nd</sup> January 2024 of the income tax department, refund can be raised only once from one challan and no further refund can be processed from that challan. Hence, such refund can be processed only once in respect of all coal buyers who have a favourable High Court Order or who furnishes Affidavit to CCL as above.

It may be noted here that such Affidavit has to be furnished to CCL within 10 days of the date of this notice.

Once the refund process is initiated after 10 days from the date of this notice, no further claim will be entertained, and the remaining parties will be required to deal with income tax department directly for refund.
