## NOTICE FOR ALLOCATION TO NON-REGULATED SECTOR (NRS) FSA CONSUMERS (RAIL MODE) FOR SEPT'2024

- All Non-Power consumers having valid FSA with CCL and drawing coal under rail mode are hereby notified to submit online rail programme through FOIS for the month of SEPT' 2024 schedule and to arrange submission of following required documents as listed below at M&S Dept, CCL Ranchi by 10-09-2024.
- a) Covering Letter specifying details of FSA, rail program and deposition of coal value.
- b) Authorisation document from consumer for supervision of loading. (If not submitted earlier)
- 2) Proforma Invoice (PI) shall be raised as per MSQ (in terms of rake load) for consumers who have filed rail program in FOIS. Consumers shall be required to make payment through Banking Interface within 48 hours of generation of PI. Alternatively, consumers may opt for One MSQ scheme in case of available coal balance.
- Non submission of rail program; non submission of required documents; non-payment shall be considered as Deemed Delivery.
- 4) For taking allotments as per CIL guidelines for desirous consumers in cases where pending value paid arrear allotments) is/are more than one month MSQ, notarized affidavit along with undertaking needs to be submitted by consumer for maintaining the advance payment equivalent to one month MSQ at any given point of time (over & above the financial coverage) and that the payment for the unpaid arrear allotted rake would be deposited before actual loading. The said affidavit should also give right to CCL for cancellation of allotments, if advance payment for one month MSQ is not maintained and /or if payment for the unpaid arrear allotted rake is not deposited before actual loading at any point of time.
- 5) Concerned consumers are also requested to deposit coal value to maintain the advance payment equivalent to one month MSQ at any given point of time (over & above the financial coverage).
- 6) LC consumers are requested to maintain a valid LC equivalent as per CIL/CCL guideline.
- 7) Consumers are also requested to mention Contract Number while filing Annexure C in FOIS.
