Sub: Notice for all NRS Consumers having FSA under Linkage Auction from 'North Urimari OCP' as Primary Source

This is for kind information to all Non-Regulated sector consumers having FSAs of G-8 grade coal under NRS Linkage Auction Scheme from 'North Urimari OCP' as Primary source with 'Urimari OCP' as Secondary source that as per Linkage Auction Policy of CIL, concerned consumers are hereby provided a dispensation to book/ lift G-8 grade coal from Urimari OCP (Secondary Source) to the tune of 100% linked quantity against such FSAs.

Such dispensation is being extended for the w.e.f quota of September'24 onwards till coal of G-8 grade gets available at North Urimari OCP. Sale Orders shall be issued accordingly from date of issuance of this notice.

For Sale orders against **North Urimari** OCP that have already been issued and sent to area, fresh sale orders will be issued after closing of Sale Orders by Area.

Further, vide notice no. CCL/HQ/C-4/2020-21/2863 dated 19.09.2020 of CCL, it has been conveyed to all Linkage Auction FSA consumsers that:

"The Seller shall endeavor to supply the Contracted Grade of Coal at the Delivery Point. In case the Seller is not in a position to supply the Scheduled Quantity of the Contracted Grade of Coal at the Delivery Point on account of a Force Majeure Act or any other reason, the Seller shall have the option to supply the balance quantity of the Contracted Grade of Coal from the secondary source(s) indicated in Annexure III ("Secondary Source(s)"). Further, in case of supply of the Contracted Grade at the Secondary Source, the Purchaser shall accept the Contracted Grade of Coal directly from such Secondary Source(s). Additional costs incurred due to supply of the Contracted Grade of Coal at the Secondary Source(s) shall be borne by the Purchaser. "
