Status of commissioning under the affidavit with Name of Plant, No. of Units with capacity. Declaration that if details are found false they will be debarred from participating in auction of coal by CIL for next one year. (as per prescribed format)

Lifting of coal

1. Bidders who have applied for CTO- The bidders whose consent to operate (CTO) has expired or is going to expire within the pendency of lifting and are yet to receive valid NOC from the respective State pollution Control Board against their application already made for renewal of CTO are required to furnish the proof of application made to the State Pollution Control Board along with an affidavit declaring that the copy of Original Certificate will be submitted within three months from the date of expiry of CTO or validity period for lifting whichever is earlier. However, the bidder along with proof of application to the State Pollution Control Board needs to submit the copy of affidavit, duly notarized if it is already submitted for participating in earlier phases of Special forward e-auction.

Bidders who are yet to apply for renewal of CTO which will expire during the pendency of lifting: Such bidders shall have to submit a duly notarized affidavit stating that they will submit the copy of application documents for renewal of CTO to the respective state Pollution Control Board and the original CTO will be submitted within 3 months from the date of expiry of the CTO or end of validity period of lifting whichever is earlier.

- 2. Deposition of coal value & taxes against monthly distributed quantity along with relevant debit advice issued by the bank
- Authorization document from buyer for lifting/supervising loading.
- 4. Commissioning certificate (if yet to be commissioned plants, participated)

After lifting

1. Power Producers shall have to furnish a certificate after utilizing the coal supplied under the auction confirming the quantity of Power Generated from such coal at the end of every quarter. The coal supplied to each TPP under such e-auction shall be informed by CIL /the supplying coal company to the concerned State DISCOMs/PTC/Power Exchange/Power Traders etc. The State DISCOMs/PTC/Power Exchange/Power Traders will issue a certificate to IPP with a copy to CIL/Supplying Coal Company regarding power supplied to them by IPP during the quarter. The IPP would submit these certificates and coal consumed for this purpose to CIL/Supplying Coal Company for reconciliation

Lifting of coal

1. Bidders who have applied for CTO: The bidders whose consent to operate (CTO) has expired or is going to expire within the pendency of lifting and are yet to receive valid NOC from the respective State pollution Control Board against their application already made for renewal of CTO are required to furnish the proof of application made to the State Pollution Control Board along with an affidavit declaring that the copy of Original Certificate will be submitted within three months from the date of expiry of CTO or validity period for lifting whichever is earlier. However, the bidder along with proof of application to the State Pollution Control Board needs to submit the copy of affidavit, duly notarized if it is already submitted for participating in earlier phases of Exclusive e-auction.

Bidders who are yet to apply for renewal of CTO which will expire during the pendency of lifting: Such bidders shall have to submit a duly notarized affidavit stating that they will submit the copy of application documents for renewal of CTO to the respective state Pollution Control Board and the original CTO will be submitted within 3 months from the date of expiry of the CTO or end of validity period of lifting whichever is earlier

After Lifting

 After lifting of coal within 4.5 months, the consumer has to provide CEA certification on utilization of coal, mentioning utilized and unutilized portion of lifted quantity.
