Sub: Supply of G-11 grade coal from Tetariakhar OCP against FSAs of G-10 grade under Linkage Auction Policy

This is in reference to our earlier notice no. CCL/HQ/C-4/RS/2024-25/2352 dtd 27.12.24 (copy attached) w.r.t. dispensation provided to book/ lift G-10 grade coal for the **quota of Dec'24 month** from **KDH OCP (Tertiary Source)** to the tune of **100% linked quantity** against such FSAs from Tetariakhar OCP (Primary Source)

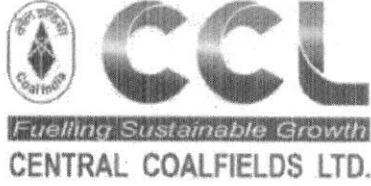
Last date for coal value deposition with respect to above shall be **22.01.2025**.

This is for kind information to all Non-Regulated sector consumers having FSAs of G-10 grade from 'Tetariakhar OCP' as Primary source that as per Linkage Auction Policy of CIL, concerned consumers are hereby provided a dispensation to book/ lift G-10 grade coal from KDH OCP (Tertiary Source) to the tune of 100% linked quantity against such FSAs from Tetariakhar OCP (Primary Source).

As of now, such dispensation is being extended for the quota of Dec'24 month only and Sale Orders shall be issued accordingly from date of issuance of this notice.

For Sale orders against Tetariakhar OCP that have already been issued and sent to area, fresh sale orders will be issued after closing of Sale Orders by Area.

For supply of coal from Tertiary Source(s), Original % bid premium of the bidder as per the FSA shall be applicable for such supply from the tertiary source. This dispensation shall be optional to the consumer and non-acceptance of supply from tertiary source shall not attract penalty.
