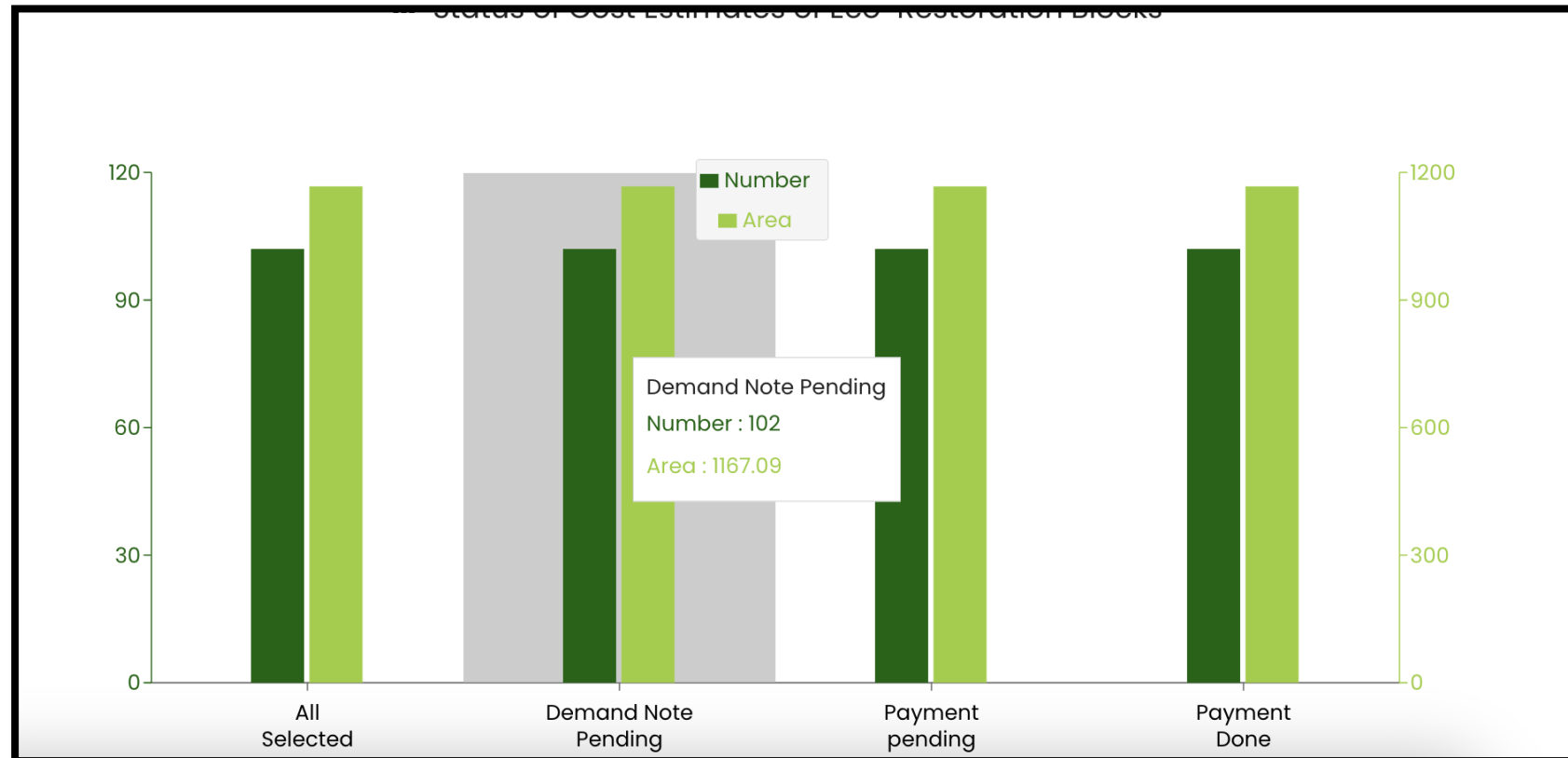

- Demand Note is awaited from respective Forest Divisions.



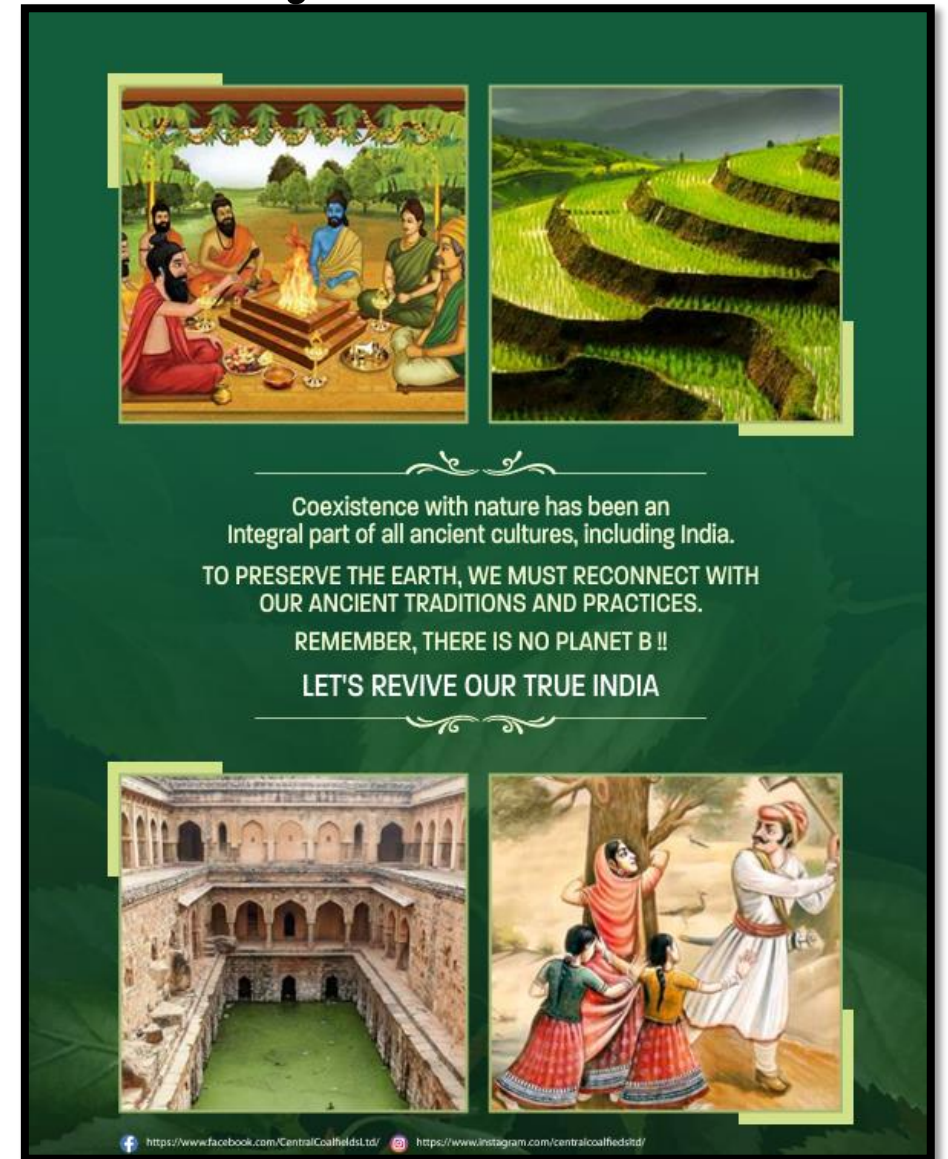
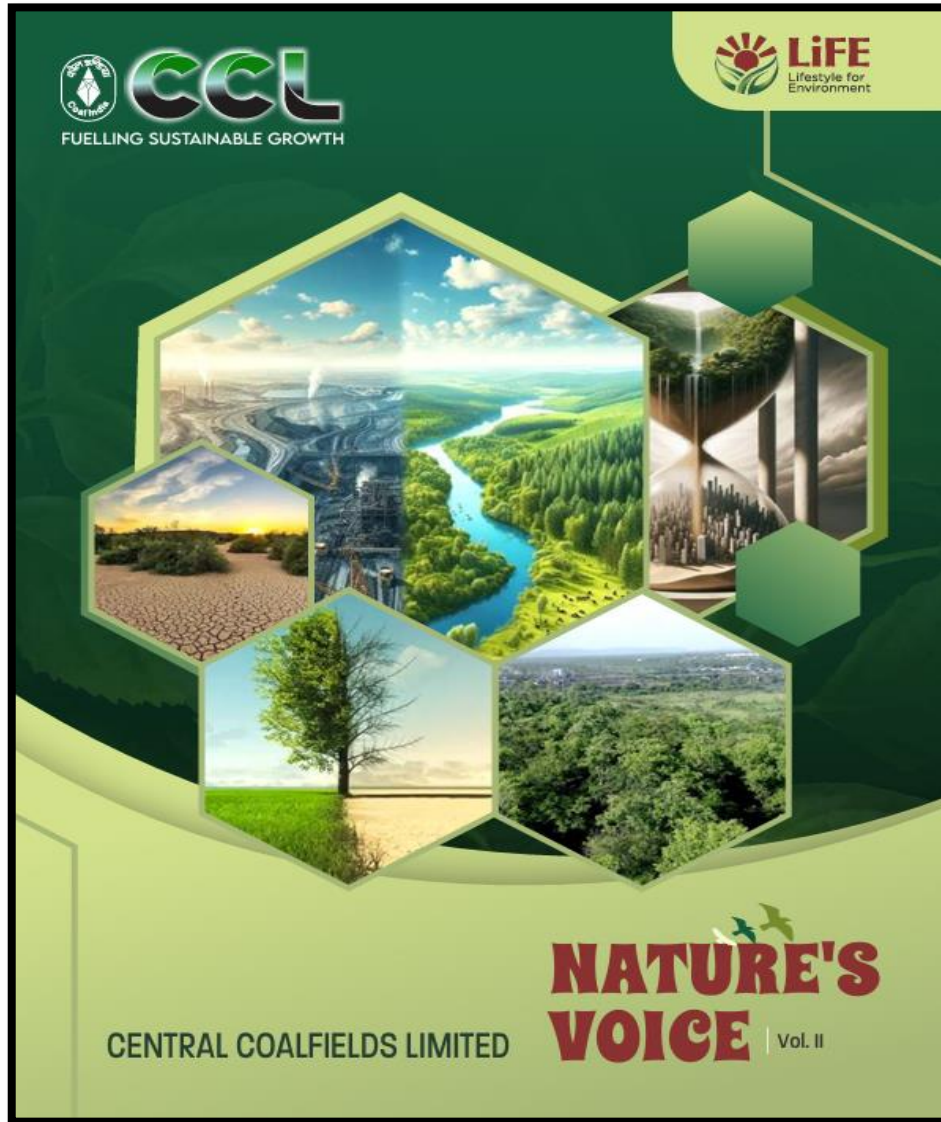
# Celebration of World Environment Day 2024

# Celebration of “Ek ped Maa ke Nam” campaign

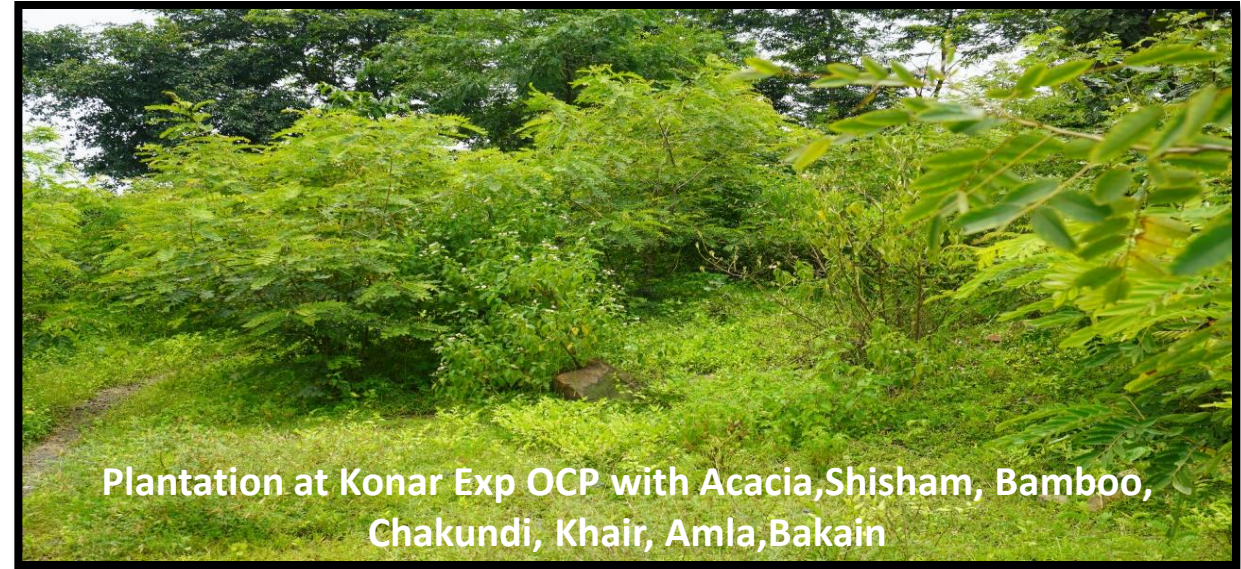
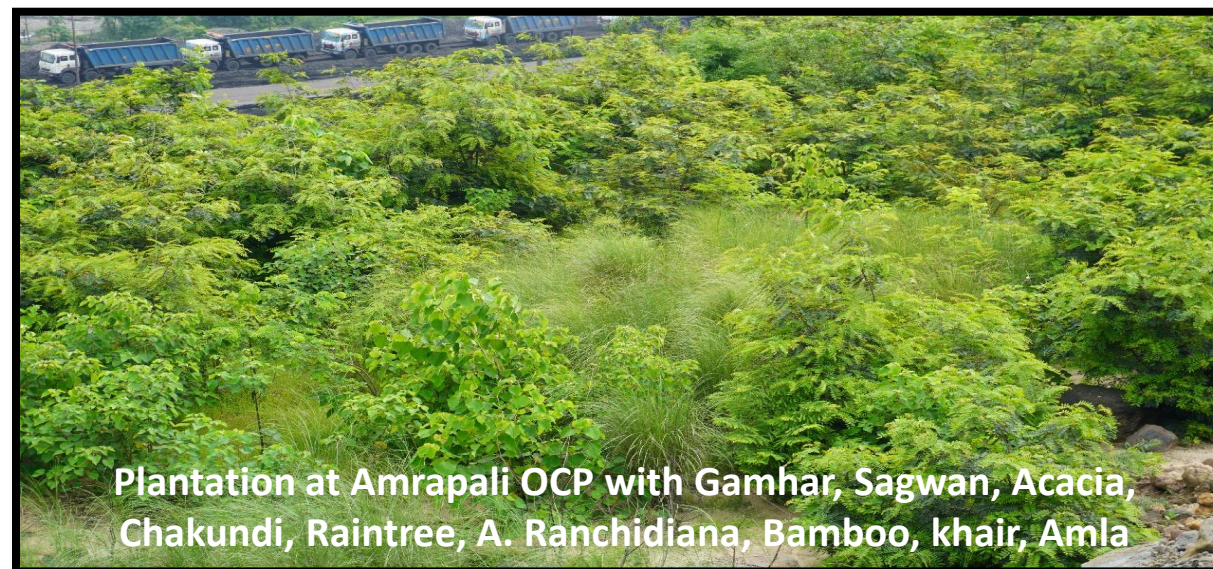
