As per statutory requirement of Mines and Minerals Dept, Govt. of Jharkhand, online mining challan has to be generated by CCL against each rake being despatched to consumers from CCL sidings. For generation of online mining challan, consumers need to be registered on JIMMS portal of Mines and Minerals Department, Govt. of Jharkhand.

Thus, it is again requested that all consumers of CCL (Power as well as Non-Power Consumers) taking coal by Rail mode should get themselves registered in JIMMS portal at the earliest for which Mining Department, Government of Jharkhand/ District Mining Officer (DMO) may be contacted.

Non compliance of above may affect loading of coal and CCL shall not be responsible for the same.

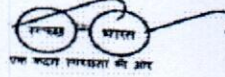


