I. COMPANY PROFILE

Eastern Coalfields Limited (ECL) a subsidiary of Coal India Limited was incorporated on 1st November, 1975 by taking over 414 mines vested with Eastern Division of Coal Mines Authority Limited (CMAL) and the company commenced its commercial operation through its registered office & head quarter at Sanctoria (near Asansol), Paschim Bardhman, West Bengal. It operates mines in Raniganj, Saharjuri and Rajmahal coalfields located in the states of West Bengal and Jharkhand. Operating locations have been divided into 13 administrative Areas, and each Area is headed by a General Manager. Further, 10 Areas are in the state of West Bengal and 3 Areas are in Jharkhand. The company carries the legacy of commencing commercial coal extraction in India at Raniganj coalfield about two and half centuries ago in 1774.

Eastern Coalfields Limited has been carrying out mining operations under its Vision to provide energy security to the country and with a Mission to produce coal efficiently in an eco-friendly manner keeping safety, conservation and quality in mind. As Raniganj coalfields hold proven reserves of high grade non- coking coal, all efforts are being made to enhance its extraction and supply to various customers in the domestic market. In addition to coal extraction, ECL has stepped into renewable energy for captive consumption, create carbon sink through mass afforestation, reduce carbon footprint/ pollution load by undertaking first mile connectivity projects to evacuate coal etc.

Eastern Coalfields Limited is a Government company within the meaning of section 2(45) of the Companies Act, 2013 and the entire equity of the company is held by Coal India Limited as holding Company. The authorized share capital of the company as on date is Rs. 4600 Crore and the paid-up share capital is Rs. 4269.42 Crore. As per Articles of Association of the company, the power to appoint Directors rests with the President of India. In terms of the Articles of Association of the company, strength of our Board shall not be less than 2 Directors and not more than 15 Directors. These Directors may be either whole-time Functional Directors or part-time Directors. The Directors are not required to hold any qualification share.

Whole Time Directors of the company are appointed by the President of India. The terms and conditions of appointment of Whole-time Functional Directors are decided by the President of India in terms of Articles of Association of the Company. The terms and condition of non-official part time directors are laid down by the Ministry of Coal. At present the Board comprises of Chairman cum-Managing Director, 3 Functional Directors, 1 Part Time Official Director from Ministry of Coal, 1 Part Time Official Director from Coal India Limited and 2 Independent Directors.

The authorized and paid up share capital of the Company was Rs.4600 crores and Rs. 4269.42 crores respectively as on 01.04.2024.

The company employed 48711 regular employees (Executives 2209, Non-executives 46502) as on 01.04.2024.

Percentage share of CIL in ECL: 100%

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Technical) is a member of the Board of Directors of ECL and reports to Chairman and Managing Director. He/She is responsible for operation of mines and also of field activities, technical functions and safety of mines.

III. ELIGIBILITY

2. EMPLOYMENT STATUS:

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and **not** in a contractual/ad-hoc capacity – in one of the followings:-

3. QUALIFICATION:

The applicant should be a qualified Mining Engineer and holder of 1st class certificate of competency under the Indian Mines Act.

4. EXPERIENCE:

The applicant should have at least five years cumulative experience/exposure during the last ten years in Mining Operations or Mine Planning at a senior management level in an organization of repute.
