Dear Sir/Madam,

In reference to earlier notification on the above cited subject, it is to inform you that the last date for receiving applications against the above scheme which was fixed as 31<sup>st</sup> August 2024 has been extended till 15<sup>th</sup> November 2024. The said scheme will stand withdrawn after 15<sup>th</sup> November, 2024 and any applications received beyond this date will not be accepted.

In this context, it is requested to spare sufficient willing employees from your subsidiary in terms of the **Scheme for re-deployment of surplus manpower by grant of incentive** circulated vide O.M no. CIL/C-5B/MP/OM/Surplus Manpower/31 dated 19.06.2024

As such, wide publicity may be given seeking applications from willing, regular employees for the above designation, as brought out in the earlier notification.

On receipt of applications at your end. A compiled list in the enclosed format as per Annexure-A, clearly specifying that the said employees are sparable may be sent to this office. A weekly report of the applications received is also required to be sent as per Annexure-B.

It is pertinent to mention that this will be treated as Administrative transfer and the following benefits will be extended:

- Grant of One-time incentive of Rs 1,00,000
- Transfer grant (1/3rd of one month's basic pay)
- Settling in Allowance (for distance more than 32 kms- 2/3rd of one month's basic pay)
- Travelling Allowance as per entitlement.
- Joining time- leave of 6 days, plus one day extra for every 500 kms.
- Reimbursement of transportation of household goods as per entitlement of TA rules
